1. Manufacturers or Dealers/Distributors/Agents duly authorized by the manufacturers or Suppliers /vendors, who are able to supply the assured quantities as per the requirement are only eligible for quoting. Failure of submission of a declaration of full supply will lead to cancellation of the tender. Further, vendors who were declared blacklisted and/or insolvent by any Govt. Concern/any Institutions in the Country for a particular item or items are not eligible to participate in the current tender for that item or items. Vendors who were earlier declared blacklisted by this University for any reasons whatsoever are also not eligible to participate in this tender.
2. Partial Quotation within the same item will not be accepted and the tender will be liable for cancellation.
3. All duties, taxes, and other levies payable by the contractor under the contract shall be included in the total price but should be indicated separately in the price bid.
4. The rate quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
5. Award of Contract: The University will award the contract to the bidder whose quotation has been determined to be the lowest bid.
6. Time Schedule: The supply and installation work must be completed within seven days from the date of receipt of the purchase order.
7. Place of delivery: Quotation should be made for Free Delivery at Chemistry Department, Kazi Nazrul University, Asansol, Nazrul Road, Kalla More, P.O. –Kalla C. H. Asansol – 713340.
8. Payment Schedule: Payment will be made after delivery and satisfactory installation of the items.
9. Quantity, as stated in the tender document, may be subject to change at the time of issuing the purchase order due to valid internal reasons of the University.
10. Bidder must have adequate documents relating to Trade License for relevant items, PAN, updated returns for Income Tax, GST registration, Audited Statement of Accounts and other documents. The bidder must submit the said documents at the time of submitting the quotations, failing which the application of the bidder will be rejected outright without assigning any reason thereof.
11. The University may take a decision about the non-purchase of the said equipment even after the selection of a vendor due to internal reasons.
14. The University reserves the right to relax any clause as stated hereinabove for the selection of a responsive vendor.
15. During the scrutiny, if it comes to the notice of the University that the credential or any other paper is found to be incorrect/manufactured/fabricated, then the bidder would not be allowed to participate in the tender and application of the bidder will be rejected outright without any prejudice.

The University will have sole discretion to decide the eligibility of bidders on the basis of submitted documents and reserves the right to reject any application and to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have been incurred by any Tenderer at the stage of Bidding.

19. No Tenderer shall be allowed to participate in the tender, if he / she / the company is associated, in whatsoever manner, with any person holding an office of profit in the University.

20. The applicant shall not do anything which will cause injury to the name or reputation of the University and that the applicant agrees to indemnify and keep the University indemnified against all liabilities, claims, damages or injury of every description which may occur or affect the University from any failure by the applicant to perform its obligations under this tender or from any act or omission whatsoever on the part of the applicant or its servants or agents.

21. In case of any dispute, the University's decision will be treated as final and conclusive. All legal actions are subject to Kolkata jurisdiction only.
