**1. QUORUM (Chapter III, Statute 50 (2), Page-53):** Half of the total number of members plus one shall form the quorum a meeting of the Committee. No quorum shall be required for an adjourned meeting.

**2. Frequency of the Meetings (Chapter III, Statute 50 (3), Page-53):** The Library Committee shall meet at least thrice in a year, preferably once in every three months.

**Note:** All decisions of the Library Committee shall be submitted to the Executive Council for confirmation. The Executive Council may approve or modify any decision of the committee or direct the committee to review its decision.
